In the reference (1) read above, the University has forwarded the proposal to the UGC for grant of Autonomous Status to Megha Institute of Engineering and Technology for Women, Edulabad (V), Ghatkesar (M), Medchal (D), Telangana State affiliated to JNT University Hyderabad, Kukatpally, Hyderabad.

In the reference (2) read above, the UGC has Conferred Autonomous Status to Megha Institute of Engineering and Technology for Women, Edulabad (V), Ghatkesar (M), Medchal (D), Telangana State affiliated to JNT University Hyderabad, Kukatpally, Hyderabad, for a period of Ten (10) Years from the Academic Year 2023-2024 to 2032-2033 as per clause 7.5 of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in autonomous Colleges) Regulations, 2023 for Autonomous Colleges and subsequent regulations issued from time to time by the University.

Also, the UGC has stated that the autonomy granted colleges shall abide by all the provisions of the UGC Regulations for Autonomous Colleges. The college shall apply, in the prescribed format to the UGC, for extension of autonomous status atleast three months before the completion of autonomy period.
